

- State support: VT, MA (stong commitment), RI (OER/N.Grid), CT(Eversource/UI), NY(NYSERDA), NH (REVEAL)- but need more support in ME
  - Carolyn talks with Richard about growing support in ME
    - Labeling IS in triennial plan, NEEP has met with interested stakeholders
- HELIX Year 1 Summit: looking to disseminate AND collect information to help guide project

#### HELIX Kickoff meeting notes



- Extension of sorts of NEEP's April 2015 meeting of regional labeling leaders
- o NEEP modifies HELIX Summit schedule for October/November timeframe
- NEEP sends project team sheets to enter fall dates to avoid and potential venue ideas likely for MA
- Even if building off SEED platform is the answer for HELIX, issues of governance and database management (Task 6) remain since someone still needs to host, operate, etc.
   Liz discusses similar models with Ahson (e.g. Medicaid)
- IT contractor: \$275,000 is included in current funding for building HELIX itself

   NEEP is exploring routes for additional funding
- Other non-DOE Home Energy Score certifications/ratings like HERS will be considered in technical scoping (and are called out in the IT budget).
  - Having all this info is what MLSs really need to get value from HELIX
  - All MLSs should be able to handle this labeling info by 2018 (RESO green fields)

### SEED update

- HPXML implementation for Home Energy Score (HES) will follow completion of Commercial Asset Score in June
- Currently HES can import HPXML but not export. SEED is working with Joan on this.
- Not many conversations yet with the ~700 MLSs nationwide. Most use third party vendors for database development maintenance (e.g. CoreLogic, Black Knight, Rapitone).
- Changing SEED ownership model
  - Completing SEED business plan over next 4-5 weeks. Two options:
    - Offload to private sector entity (after core code is developed) that will provide visualization/analytics and platform mgmt
    - 2. Offload to nonprofit/NGO that will mange user base & code base, and handle communications outward
    - NEEP communicates decision made to whole group at June 1 meeting
  - Note: this is a strategic decision, and actual changes not being made until 2017
  - Carolyn reports back on Better Buildings expo on what 3rd parties are adding on to SEED

#### **Observer list (brief update / overview of current efforts)**

- In the 12 state NEEP region, something is going on in regards to labeling in each state
- REVEAL VT/NH project working on increasing number of labeled homes
  - Currently in year 2. 18 people have passed HES training (incl. 1 home inspector)
  - VT homeowners will have to pay for it, and are more focused on time of sale
    - The market driver for \$300/\$500 score is TBD. An energy inspection add on by home inspectors would be key mechanism for mobilizing this.
    - Ricard- 250 VT home baseline will also be provided as part of NMR study baseline (these will be informal)
    - Liz follows up with Craig on real estate realities in VT

#### HELIX Kickoff meeting notes



- NH further behind. GDS is acting as provider and using existing DOE systems wherever possible. Also focusing on market based approaches.
- Parallel efforts outside the northeast region
  - Build it Green (California)
    - Working on similar effort to HELIX. They have a group of volunteers working on the project who have figured out IT issues.
      - Key differences from HELIX: not open source and state level
  - Oregon Trust
    - EMPRESS project (HERS-HES alignment) participant.
    - Have indicated interest in funding/contributing to HELIX.
  - o Earth Advantage
    - Provide IT/data management services to many labeling projects throughout the country
- DOE PV Auto-Pop Roadmap project
  - $\circ~$  MA and San Diego are currently writing roadmap for implementing PV info autopopulation into MLSs.
  - On HELIX team, Craig, Carolyn, Alissa, and Kevin J (plus Mark and Roxana), are part of this.
  - MA is now auto-populating PV info through MA Clean Energy Center and Warren Group (data aggregator)
    - HELIX could serve as the way to connect disparate data sources so to streamline connection to MLSs.
  - Info exchange through software APIs might not always be the pathway need to get the MLSs engaged in all states.

#### Develop stakeholder list

- States, utilities, local efforts (e.g. REVEAL), MLSs (e.g. NEREN), real estate orgs (e.g. RI Association of REALTORS), LBNL (PV APR), Elevate (HEI Accelerator)
  - NEEP sends HELIX outreach list sheet for everyone to add individuals (organized by industry/role)
- Automated energy modeling groups (e.g EnerScore, ClearlyEnergy)
  - All team members should channel information through NEEP
    - We need to be on the same page at least since they are talking with real estate portals.
- Should develop guidelines for people who are looking to get business from this.
  - NEEP sets up public webinar and private opportunities for feedback from these groups (RFI).
