

Policy Factsheet: Bipartisan Infrastructure Law

In November 2021, the federal government passed the historic Bipartisan Infrastructure Law. It allocated \$62 billion for infrastructure and other costly capital projects with investments in clean energy, building efficiency, transportation systems, broadband and communications networks, and more. This fact sheet highlights those grants that support building electrification, energy efficiency, and workforce development.
