NEEP is seeking a full-time Energy Policy Associate who will be an integral member of the organization's team that seeks to reduce energy use in homes and buildings across the region through public policy and practices. This person will primarily be responsible for providing analysis of building energy codes, high performance building energy standards, and building energy rating programs to inform NEEP's projects to advance strategies that result in long-term energy savings. This position is especially relevant as communities determine their responses to climate change and resiliency and work to build an equitable economic recovery.

Reporting to the Senior Manager of Buildings & Community Solutions, the Energy Policy Associate will play an important role in helping NEEP achieve its long-term visions of zero energy homes and buildings throughout the region.

Key Responsibilities

Support NEEP's Building & Communities Team to deliver project goals, including the following:

- Conduct analysis of building energy policies, such as energy codes, building energy standards, and building energy rating programs
- Provide direct technical guidance to state energy offices, utilities, efficiency program administrators, and other key partners
- Contribute to and help lead stakeholder discussion forums organized by NEEP to facilitate information exchange and knowledge transfer between state policymakers and other partners
- Serve on and/or support external working groups or committees focused on building energy codes or building energy standards
- Lead or assist with development and dissemination of tools, resources, and reports to support enhanced building energy efficiency
- Interface with national building-related programs to promote successful local deployment of programs in the region



- Help maintain an inventory of building energy policy developments in NEEP's 13-state region
- Facilitate the automation of home energy information into Multiple Listing Services by supporting our HELIX project
